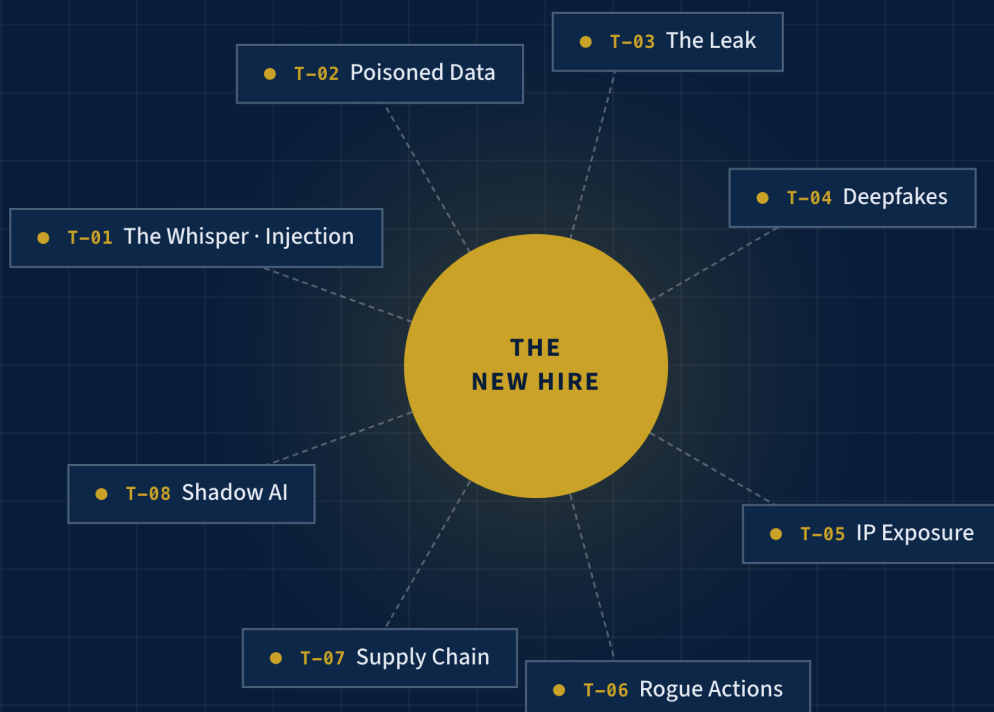

What a Certified AI Systems Security Architect can *demonstrate*.

The credential is defined by demonstrable capability, not tool coverage. Architects are not expected to master every platform. They are expected to see the whole board and prove it.

01 Map an organization's AI exposure.

02 Decompose any AI system into model, data, and agent.

03 Classify the six durable attack types.

04 Brief a team on AI-powered social engineering.

05 Audit data and IP exposure.

06 Apply the six defense principles.

07 Identify defensive-AI use cases.

08 Scope which AI regulations apply.

09 Assemble an organizational AI Security Blueprint.

10 Run the pre-implementation checklist.

GAISB ASSESSMENT PRINCIPLE

The credential requires a completed *AI Security Blueprint*.

Every candidate assembles and submits one AI Security Blueprint, built layer by layer through the nine labs, meeting the published GAISB standard before the credential can be issued.



RECORDED BLUEPRINT WALKTHROUGH

The candidate records an 8–12-minute walkthrough explaining the exposure map, the threats prioritized, the defenses chosen, and the governance decisions behind them.

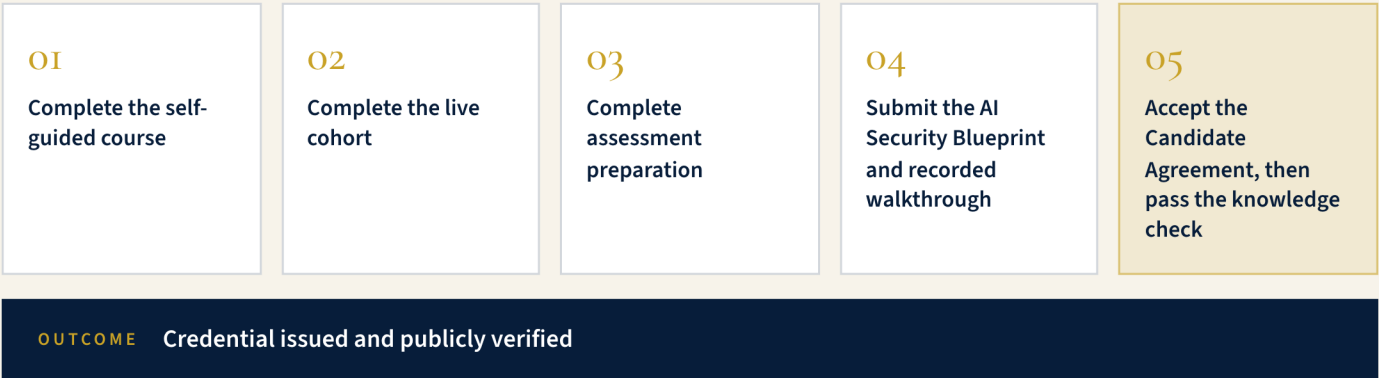
Candidates may use their own organization, employer, or an approved simulated case.
